

ID06 cards for third country citizens

1. THIRD COUNTRY CITIZENS EMPLOYED BY SWEDISH COMPANY

1.1 Third country citizens that has a residence or a working permit from the Swedish Migration Agency
Swedish companies based in Sweden can register ID06-cards to third-country citizens who have residence and work permits
issued by the Swedish Migration Agency.

Documentation attached digitally with the card order:

- Photo on the individual's EU residence permit card or work and residence permit from the Swedish Migration Agency with the decision that the individual is permitted to work in Sweden.
- However, it may only be stated on the card or in the decision that the person has a permanent residence permit, which means that the person automatically then also has the right to work.

ID06 cards can be issued with a validity period:

- The ID06 card's validity shall be equal to the Swedish Migration Agency decision concerning the validity of the work and residence permits if Swedish personal identity or coordination number exists
- If there is no Swedish personal or coordination number, the ID06- card is issued for a maximum of 3 months and then with a requirement that the Swedish Tax Agency's receipt of application for special income tax or notification of A-tax is attached to the order.
- An ID06 card for 3 months with the Swedish Tax Agency's receipt of application for special income tax or
 notification of A-tax can only be ordered twice for one person, thereafter there is a requirement for a Swedish
 personal identity number or coordination number.

Note: According to Swedish legislation, a Swedish company is not allowed to employ persons with an EU residence permit card from a country other than Sweden and consequently cannot get an ID06 card issued. The exception is long-term residence in the EU. (The exception is long-term 'long-term residence' in the EU, see point 1.3)

1.2 Third country citizen that has applied for a prolonged work and residence permit

Third country citizens that has had a work and residence permits in Sweden for at least six months and has applied for an extension of the work permit during this time, is also allowed to work in Sweden during the waiting period until the application is processed by the Swedish Migration Agency, which can take up to two years.

Documentation attached digitally with the card order:

• The earlier work permit that has ceased to be valid and the Swedish Migration Agency written confirmation that they have received the application for the extension of the working permit.

ID06 cards can be issued with a validity period:

- The ID06 card can be issued with a maximum validity of one year from the date that is given on the Swedish Migration Agency written confirmation that they have received the new application and if Swedish personal or coordination number exists
- If there is no Swedish personal or coordination number, the ID06-card is issued for a maximum of 3 months and then with a requirement that the Swedish Tax Agency's receipt of application for special income tax or notification of A-tax is attached to the order.
- An ID06 card for 3 months with the Swedish Tax Agency's receipt of application for special income tax or notification
 of A-tax can only be ordered twice for one person, thereafter there is a requirement for a Swedish personal identity
 number or coordination number

1.3 Third country citizen that are Long-term residence

A third country citizen that can show a EU residence permit card issued in another EU country where it is indicated that he or she has the status of *Long-term residence** are exempted the demands of a work permit in Sweden. However, there is a legal requirement for a Swedish residence permit if the person is to stay for a longer than 3 months in Sweden over a 6- month period

Documentation attached digitally with the card order:

- Photo on the EU residence permit card with Long-term residence indicated on the card
- Photo of the applicant's third country citizens residence permit in Sweden issued by the Swedish Migration Agency if an ID06 card is to be issued for a period longer than 3 months during a 6-month period. (work permit does not need to be stated on the residence permit)

ID06 cards can be issued with a validity period:

- ID06 cards can be issued with the same validity period as a Swedish residence permit when a Swedish personal or coordination number is available.
- If there is no Swedish residence permit and / or Swedish personal or coordination number, the ID06 card is issued for a maximum of 3 months during a 6-month period and then with the requirement for the Swedish Tax Agency's receipt that the application for special income tax or notification of A-tax is attached to the order.
- A receipt or document from the Swedish Migration Agency stating that the application for a Swedish residence permit has been served on them is also accepted instead of the actual residence permit and an ID06 card can be issued for 3 months from the date of receipt stated on the Swedish Migration Agency receipt / document on application for residence permit. But after the 3-month period, a new ID06 card cannot be issued, but it must then be the actual approved residence permit that is attached to the ID06 card order.
 - Exceptions are allowed if there is a letter issued by the Swedish Migration Agency stating that a decision has not yet been made regarding the third-country national's application for a residence permit

1.4 Family members to a EU citizen or a long-term residence

Third-country citizen who are family members* to an EU citizen or to a Long-term residence (long-term resident) living in Sweden are exempt from work permit requirements.

Documentation attached digitally with the card order:

- Photo of the EU citizen's passport or the Permanent Resident's passport and residence permit issued by the Swedish Migration Agency with a long-term residence (permanent resident) stated.
- Photo of the applicant family member's residence permit or application for a residence permit issued by the Swedish Migration Agency and a Swedish personal or coordination number or receipt of an application to the Swedish Tax Agency for special income tax or notification of A-tax.

ID06 cards can be issued with a validity period:

- ID06-card can be issued with the same validity period as a Swedish residence permit when a Swedish personal or coordination number is available.
- ID06-card can be issued for 3 months with the condition that the application receipt / document on residence permit to
 the Swedish Migration Agency and the Swedish Tax Agency's receipt on application for special income tax or
 notification of A-tax is attached to the order.
- An ID06-card for 3 months with application receipt / document on residence permit and receipt on application for special income tax or application for A-tax can only be ordered twice for one person thereafter, there is a requirement for an approved residence permit and Swedish personal or coordination number.

1.5 Third country citizen who is a university student in Sweden

Students that have a residence permit in Sweden for studying at a university, have the right to work without a work permit during the validity of the residence permit.

Documentation attached digitally with the card order:

 Photo on the student's residence permit card, issued with "Student" on the card and it doesn't need the status of "Right to work".

ID06 cards can be issued with a validity period:

- ID06- cards can be issued with the same validity period as a Swedish residence permit when a Swedish personal or coordination number is available.
- If there is no Swedish personal or coordination number, the ID06 card is issued for a maximum of 3 months during a 6-month period and then with the requirement for the Swedish Tax Agency's receipt that the application for special income tax or notification of A-tax is attached to the order.

1.6 Third-country nationals who have completed their university education and obtained employment.

Third-country nationals who have had a residence permit in Sweden for studies at a university or college and applied for a work permit before the residence permit expired may also work in Sweden while waiting for a decision, which can take up to a year.

Documents to be attached digitally with the card order:

- Photo of the student's residence permit card
- Photo on the application for a work permit at the Swedish Migration Agency
- Photo of the Employment Agreement specified with the same employer as the company/employer who wants the ID06 card issued to the person.

ID06 cards can be issued with validity periods:

- ID06 cards can be issued with a validity period of one year counted from the date stated on the Migration agency's
 written confirmation that they have received the application document and if a Swedish personal or coordination
 number is available
- If a Swedish personal number or coordination number is missing, the ID06 card will be issued for a maximum of 3 months and then with the requirement that the Tax Agency's receipt of the application for special income tax or notification of A tax be attached to the order.
- An ID06 card for 3 months with the Tax Agency's receipt of application for special income tax or notification of A-tax
 can only be ordered 2 times for one person, after that a Swedish personal identification number or coordination
 number is required.

2. THIRD COUNTRY CITIZEN EMPOYED IN FOREIGN COMPANY

2.1 Third-country citizens with the right to work in Sweden for a limited time:

Foreign companies domiciled in an EU / EEA country other than Sweden may register ID06- cards to third-country citizen who have EU residence permit cards that are issued with Residence Permit (residence permit). However, it must be issued with at least **one years** of validity and also stated with the **right to work** or other text with the same meaning, English or in the country's own language on the front or back. (Exception is an EU permanent residence permit card that does not need to be specified with the right to work)

With the EU residence permit card, the posted third-country citizen has the right to staying in Sweden for work for 3 months over a 6-month period.

Documentation attached digitally with the card order:

- Photo on the third country citizen's EU Residence Permit card front and back indicated by Residence Permit and
 Work Permit and issued with at least one years of validity. It must be a clear photograph on the front and back of the
 EU residence permit card, photocopy will not be accepted. (Exception is an EU permanent residence permit card that
 does not need to be specified with the right to work)
- Copy of A1 certificate or confirmation of application of A1 certificate is a requirement.

ID06 cards can be issued with a validity period:

- ID06-card can be issued with a maximum validity period of three months over a 6-month period
- But with a Swedish residence permit issued by Migration Agency in Sweden, the ID06 card can be issued for the time
 the Swedish residence permit is valid for, but no longer than the A1 certificate or application for an A1 certificate is
 issued to
- A receipt or document from the Swedish Migration Agency stating that the application for a Swedish residence permit
 has been served on them is also accepted instead of the actual residence permit. And an ID06 card can be issued for
 3 months from the date of receipt stated on the Swedish Migration Agency receipt / document on application for
 residence permit. But after the 3-month period, a new ID06 card cannot be issued, t it must then be the actual
 approved residence permit that is attached to the ID06 card order.
- Exceptions are allowed if there is a letter issued by the Swedish Migration Agency stating that a decision has not yet been made regarding the third-country national's application for a residence permit.

Conditions for EU residence and work permit cards:

ID06 does not accept documents other than the EU residence permit card stated with the right to work with validity of at least **one year** for verification of third-country citizen **residence** in the EU country from which they are posted. It is then that national legislation that applies to the right of third-country nationals to work in another EU country and Swedish legislation requires that the third-country citizen be resident in the EU country from which they are posted.

A third-country citizen with the right to work in an EU country for a short, limited time is by definition not resident in that EU country. Accordingly, ID06 will not accept documents that are in violation of Swedish legislation, as a stay for short-term employment in another EU / EEA country, nor will VISA D be accepted. None of those documents give the right to third-country citizen to be posted from another EU / EEA country for work in Sweden.

Foreign citizen employed by foreign companies are required to have an A1 certificate or a confirmation of the application for A1 issued by an authority in the home country. If a confirmation of the application is attached instead of the A1 certificate, then when ordering an ID06 card, the A1 certificate must be supplemented by the customer within 3 months.

The A1 certificate must state the same company as the ordering company of the ID06 card

EU rules do not allow companies to post persons other than their own employees who are then socially insured in the same country in which the company is domiciled. The company name and domicile / registered office in the same country as the employee is socially insured in must then be stated on the A1 certificate (and notification of the A1 certificate)

Example of EU residence permit cards - the same layout in all EU countries



2.2 A third country citizen that is a <u>specialist</u> in an international group: Can work temporarily in Sweden for the group for a shorter time than one year without a work permit. However, it is statutory that a Swedish residence permit is required for a stay in Sweden for longer than 3 months during a 6-month period. It is also a legal requirement for third-country nationals from certain countries to have a valid visa for a stay within Schengen. Documentation attached digitally with the card order:

- Photo on the third country citizens employment agreement stated with the individual's profession and documents that shows that the company is part of a international group.
- · Valid visa for stay within Schengen.
- Valid A1 certificate if the third-country national is posted by a company based in an EU country.

ID06 cards can be issued with a validity period:

- An ID06 card can be issued with the same validity period as a Swedish residence permit If there is no Swedish
 residence permit, an ID06 card is issued for a maximum of 3 months during a 6-month period.
- 2.3 A third country citizen with the profession of being a fitter or technical instructor and in connection with an urgent installation or repair of machines, for as long as two months: Are excepted from a work permit. The cause for the work shall be of a crisis's situation. This means that something unpredicted has happened which requires fast measures. It is also a legal requirement for third-country nationals from certain countries to have a valid visa for a stay within Schengen. Documentation attached digitally with the card order:

- The profession of third-country citizens and the geographical location of the workplace must be stated. The ordering Swedish company and contact person for the urgent work must also be stated in the ID06 application and saved together with the application documents.
- Valid visa for stay within Schengen.
- Valid A1 certificate if the third-country national is posted by a company based in an EU country.

ID06 cards can be issued with a validity period:

- The ID06 card can be issued with a maximum validity of two months.
- 2.4 Third-country citizens who, in the context of a business settlement, are required to carry out tests, prepare or end deliveries on a construction site for a total of three months during a period of 12 months. It is also a legal requirement for third-country nationals from certain countries to have a valid visa for a stay within Schengen. Documentation attached digitally with the card order:

- The profession of third-country citizen and the geographical location of the workplace must be stated. The ordering Swedish company and contact person for the business agreement must also be stated in the application to ID06 and saved together with the application documents.
- Valid visa for stay within Schengen.
- Valid A1 certificate if the third-country national is posted by a company based in an EU country.

ID06 cards can be issued with a validity period:

ID06-card may be issued with a total period of validity of 3 months during a 12-month period.

3 Third country citizen as Sole trader

Note: the following applies only to the person who is self-employed and, consequently, not to third-country citizens the self-employed person may have as employees.

3.1 Third-country citizens who are to stay in Sweden for longer than three months to start and run their own company or join as a partner in a company, then he or she must have a Swedish residence permit and be registered for F-tax in Sweden.

Documentation attached digitally with the card order:

Photo of the third-country citizens Swedish residence permit or receipt / document with application for residence
permit issued by the Swedish Migration Agency and the Swedish Tax Agency's extract from Swedish F-tax or receipt
or registration number (RUFS) for application for F-tax.

ID06 cards can be issued with a validity period:

- A maximum of 3 months during a 6-month period when the receipt or RUFS number for the application to the Swedish Tax Agency for Swedish F-tax is available.
- A maximum of **6 months** when the application for a residence permit to the Swedish Migration Agency and the application for F-tax to the Swedish Tax Agency are available.
- Maximum with the same period of validity as the Swedish Migration Agency's issued residence permit and then
 conditional that the Swedish Tax Agency's register extract on Swedish F-tax is available.
- **3.2** Third country citizen who is a **sole trader** in his homeland and is going to work for a shorter time than three months in Sweden does not need a residence permit but still registered for F-tax. For work shorter than three months, some citizens must have a visa. Documentation attached digitally with the card order:

• Photo of the third-country national's visa (if a visa is required) and the Swedish Tax Agency's register extract on Swedish F-tax or receipt or registration number (RUFS) on the application for F-tax.

ID06 cards can be issued with a validity period:

 A maximum of 3 months during a 6-month period provided that F-tax or receipt or RUFS number for the application to the Swedish Tax Agency for Swedish F-tax is available.
